PRICES, TARIFFS AND EXCHANGE RATES: The rates quoted are based on tariffs and foreign exchange rates effective as of the date of quotation and are subject to change without notice.

TAXES, SERVICE CHARGES: Most package prices include all government and local taxes and service charges for service provided as specified in the itinerary if possible. However airline ticket purchases, tours that include air, Hotel rooms, car rental and other miscellaneous items may require additional tax. Tour prices include charges for research, itinerary preparation, planning, currency exchange, booking procedures and the services of local tour operators representing Graham Euro Designs, Inc.. In each quoted package an itemization of individual components will not be rendered under any circumstance.

PRICES: All prices are based on individual travel and include: double occupancy accommodations or as noted per itinerary, English-speaking qualified guides and lecturers where noted, transfers where noted, meals as described in itineraries, and all other items in the package.

NOT INCLUDED IN THE TOUR PRICE: Tour prices do not include charges for passports, visas, or meals not specified in the itinerary, excess baggage, personal and accident insurance, beverages, telephone calls, all items of personal nature or any service not specifically mentioned as "included" in the itinerary. Application for passport and visas is the responsibility of each individual traveler.

*Gratuities are not included except if it is specified as an "included" item.

*Food and beverages are not included except if it is specified as an "included" item.

*Transfers are not included with tours, unless otherwise specified.

*Tours, which include rail transportation, do not include transfers to/from rail stations unless specified.

*Train tickets do not include seat assignment. Train seat assignments may be arranged for minimal charge.

SCHEDULED SIGHTSEEING TOURS are not pre-reserved. Local operators reserve the right to change schedules or cancel tours without notice.

DEPOSIT AND PAYMENTS: All bookings require a minimum of \$500 per person deposit at time of reservation and are non refundable.

*Full payment is due 60 days prior to departure.

*Reservations made within 45 days, full payment is due within 7 days.

*Reservations made within 15 days of departure from the US may require special courier delivery of the documents at the client's expense.

*Graham Euro Designs, Inc. dba Europe Made Easy accepts agency checks for payment. Credit card payments accepted for final payment with a 5% surcharge for credit card fees.

*Tour documents will not be released until full payment has been received.

Please note: If full payment is not received by the due date, reservations may be automatically canceled and penalties will apply.

LATE BOOKING FEE: If your reservation is made within 15 days of US departure date, then a \$50 per reservation, late booking processing fee will be charged. **SOME MISCELLANEOUS** arrangements maybe subject to a minimum \$25 processing fee.

CANCELLATION/REFUNDS

Deposit towards booking constitutes full knowledge and acceptance of our cancellation policy. Cancellation must be received in writing, along with all travel documents, before it will be processed. Regardless of the cause, the following terms will apply upon cancellation: Deposit is 100% non refundable once package is confirmed with hotels and service, after final payment and 60 days or less prior to departure: No refund for the tour price. Graham Euro Designs, Inc. has the right to substitute or change the tour.

Our agents will not be responsible for any damage, expense or inconvenience caused by late arrivals or departures, change of schedule, weather, strikes or any other conditions including baggage delay or loss. Travelers are advised that itineraries cannot be altered, Graham Euro Designs, Inc. reserve the right to book other hotels within the same or upgraded category even if the travel documents have already been issued.

NOTE: The IATA carriers, steamship lines and other transportation companies are not held responsible for any act, omission, or event during the time passengers are not on board their respective conveyances. The passage contract in use by these companies and the purchaser of these tours shall constitute the sole contract between the transportation company and passengers.

According to airline regulations, a cancellation fee can be charged. Rail passes are subject to a minimum 50% handling fee.

REFUNDS: Refund requests must be made in writing within 30 days of cancellation. The written request must include necessary information to process the request. Once travel has commenced, there will be no refunds for unused portions of travel. Please allow a minimum of 4 weeks to process refunds. A \$300 processing fee will be charged for refunds.

PRICES ARE SUBJECT TO CHANGE: In the event of a price increase, the client will be subject to the increase unless the reservations have been paid in full. Any changes made to a reservation for which the price has been guaranteed will result in the booking being re-priced at the prices and airfares in effect at the time the re-routing. In case of currency fluctuations of more than 3% or amendments in local government taxes, we reserve the right to adjust the tour price accordingly. Packages are quoted for the number of participants that are guaranteed, if the number changes pricing will adjust.
